

PRIVACY POLICY

By using our Web site, you agree to comply with our policies. Our Privacy Policy is designed to assist you in understanding how we collect and use the personal information you provide to us and to assist you in making informed decisions when using our site and our products and services.

What Information Do we Collect?

When you visit our Web site you may provide us with two types of information: personal information you knowingly choose to disclose that is collected on an individual basis and Web site usage information collected on an aggregate basis as you and others browse our Web site.

Personal Information You Choose to Provide

Registration Information.

You will provide us information about yourself that will enable us to verify whether you are entitled to access and use certain information, materials and services available from the Web site Rik Academy This information may also be used to enable us to enhance your Site visit, to assist you with customer service or technical support issues, or to follow up with you after your visit, or to otherwise support your relationship with P2P Blockchain Technologies Pvt Ltd It is completely optional for you to participate. In each of the instances above, we typically ask for your name, e-mail address, phone number, address, Log in Name and Password, as well as, other similar personal information that is needed to register or subscribe you to services or offers. On occasion, we may ask for additional information to enable us to provide you with access to and use of certain information, materials and services. In the case of newsletters or mailing lists, you will be able to “unsubscribe” to these mailers at any time.

How we use information

P2P Blockchain Technologies Pvt Ltd uses your personal information for specific purposes only. The personal information you provide to us when using the Web site, such as your name, postal, e-mail address or telephone number will be kept confidential and used to support your relationship with P2P Blockchain Technologies Pvt Ltd to notify you of special offers, updated information and new products and services from P2P Blockchain Technologies Pvt Ltd, or offers from third parties that we think may be of interest to you. Agents or contractors of P2P Blockchain Technologies Pvt Ltd who are given access to your personal information will be required to keep the information confidential and not use it for any other purpose other than to carry out the services they are performing for Rik Academy.

Sharing information with Third Parties

P2P Blockchain Technologies Pvt Ltd may enhance or merge your information collected at its Web site with data from third parties for purposes of marketing products or services to you. Cookies

A cookie is a very small text document, which often includes an anonymous unique identifier.
